1. To comply with all the visions of the Articles of Cooperation and By-Laws, policies set by the Board of Directors and the General Assembly, as well as acts of otherwise known as RA 9520 and failure on my part to do so, the CPMPC, at its option may: (a) Fine, (b) Suspend, or (c) Expel me from membership, where all my deposits and share holdings in, shall be answerable for my liabilities to the Cooperative.
2. To attend membership and other special meetings conducted for the members of the Cooperative.
3. To subscribe at least five (5) shares with a total value of two thousand five hundred (Php2,500.00) pesos of which at least five hundred (Php500.00) pesos corresponding to one (1) share shall be paid upon submission of the application.
4. I understand that to be able to enjoy the rights, privileges, and benefits of the Cooperative, I must be a Member-In-Good-Standing (MIGS) and meet the criteria as follows:
 - Has attended the required PMES.
 - Participated in the Capital Build Up or CBU by contributing at least one thousand two hundred pesos (Php1,200.00) per year or a monthly contribution of at least one hundred pesos (Php100.00).
 - Has paid an annual dues of fifty pesos (Php50.00).
 - Participated with the Coop Health Care and Mortuary Programs known as (a) SSP Plus and (b) Family Damayan Program respectively.
 - Has paid all loan obligations on time without default.
 - Patronizing the Savings or Time Deposit products by maintaining at least not less than the average daily Maintaining Balance of Eight hundred pesos (Php800.00) or at least One thousand (Php1,000.00) peso Time deposit placement in the cooperative.
 - Has recruited at least three members every year.
5. To use or patronize other products and allied services of the Cooperative.
6. To comply with the directives of the duly constituted authorities as well as the decisions of the Board of Directors regarding the operating policies of the Cooperative.
7. To help realize the Vision, Mission, and Objectives of the Cooperative, the success of its business, the welfare of its members, employees, community and the cooperative moment as a whole.

I understand the provisions of this application and agree to abide with all of them.

In all of the above undertakings, I am aware that the Board of Directors and the Cooperative may impose or perform any act necessary to make any sanction/s effective without going to court.

I understand that any false information or submitted documents is sufficient ground for legal action and/or rejection of my application or expulsion of my Coop Membership. I also understand that should my application be denied, Cebu People's Multi-Purpose Cooperative has no obligation to furnish the reason for such rejection.
